The Impact of the Infrastructure Investment and Jobs Acts on MBEs (Co-hosted by the National Urban League)

The Infrastructure Investment and Jobs Act is a clear massive scalable opportunity for the federal and state local government to help enable racial, economic equity and for minority businesses and communities to build for the future with direct opportunity. The global pandemic and continued economic, social, and racial health disparities in the United States aggregate more profound long-term challenges to communities of color. The Infrastructure Investment and Jobs Act can be leveraged as an opportunity to create systemic change that can catapult progress for generations to come. While Minority Businesses are contributing to the economic vitality of communities of color and the American economy by addressing social issues in new ways, they must have the opportunity to develop capacity and entry points into the industries of tomorrow. To address the historically disproportionately low amount of federal infrastructure contracts awarded to minority-owned businesses, the infrastructure bill includes a passage that breaks up large federal contracts into smaller deals that would allow minority-owned firms tremendous opportunities.
